9. The region is experiencing unprecedented growth. Ellenville has not fully participated as a result of neglect of infrastructure and failure to maintain both commercial and residential structures. I want to focus on creating an environment in Ellenville to fully benefit from renewed interest in the upstate New York region.
10. Greatest strength/expertise/ability would bring to job: Thorough knowledge of local municipal law and what needs to be done to start turning around years of neglect.
11. Would like to accomplish most while in office: Improve quality of life in the Village of Ellenville.
12. AND 13. I believe the most important short-term and long-term problem is to clean up Ellenville in both the business and residential districts to create a positive environment for future growth.

14. The public has lost confidence in government's ability to find answers to the problems they face. We must win back the people's confidence. I believe we must reach out to the community rather than asking the community to come to us. Workshop sessions which precede village meetings will be replaced by neighborhood walks through rotating areas in our village, personally inviting residents and property owners to join on these walks with the board, the village building inspector, the village manager, and the public at large.

To attract and keep businesses in the Ellenville area, create a clean, positive, and attractive environment that will encourage the traffic that passes through our community to stop; assist new businesses in finding locations in the community with the best likelihood to succeed, and assist in finding funding and available government programs for new businesses.
17. The best way to reduce taxes is by increasing our tax base and using municipal services to raise revenues.
18. Ellenville is a small urban community in a rural area. I believe the problems facing our Village can best and most expediently be corrected by focusing energies on these problems rather than consolidating government. It will clearly take the focus away from what must be done to make Ellenville a better place to live to attempt dissolution at this time.
